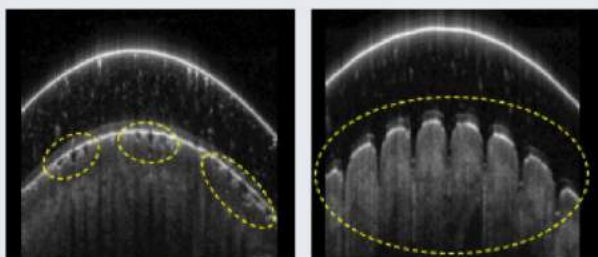

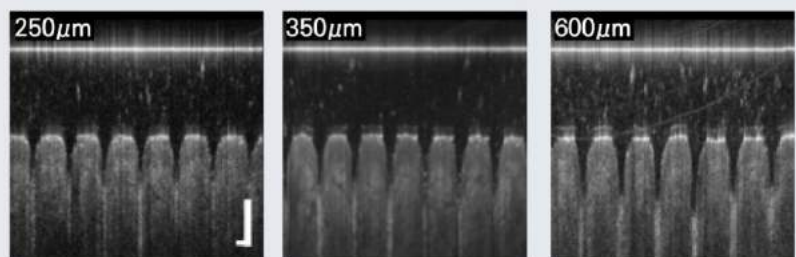
Microcone insertion capability based on the manufacturing technology

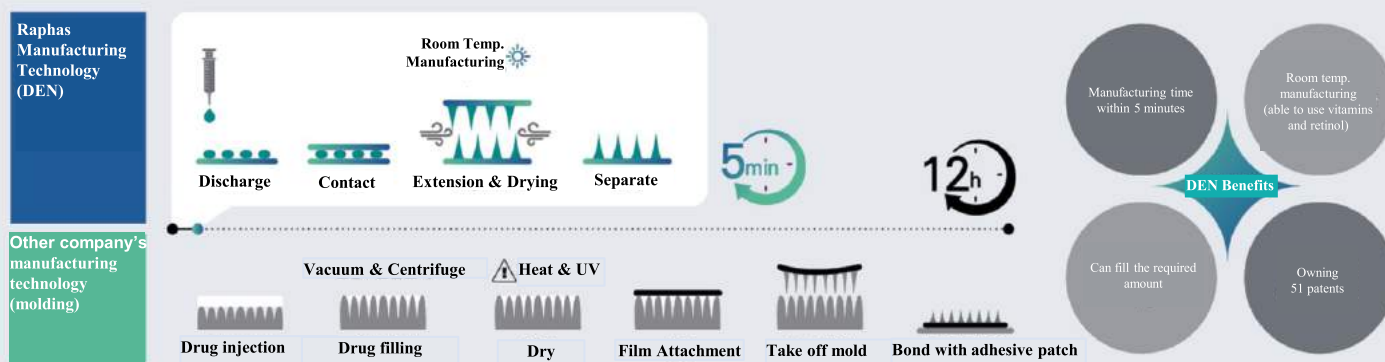
